VAN FLEET, EVANS PRESENT CLE ON EMPLOYEE BENEFITS HOT TOPICS

Bryan Cave Leighton Paisner St. Louis Partner Lisa Van Fleet and Associate Stephen Evans presented a live webcast CLE April 14 for the Bar Association of Metropolitan St. Louis on Employee Benefits Hot Topics: COVID-19, the SECURE Act, and the CARES Act.

The two gave an overview of the SECURE Act's impact on employer-sponsored retirement plans and led a discussion of how the COVID-19 pandemic and congressional response impacts employer-provided health and welfare and retirement benefits, including the Families First Coronavirus Response Act (FFCRA) and the Coronavirus Aid, Relief, and Economic Security Act (CARES Act).
