CHAMBERS 2025 UK GUIDE RANKS BCLP IN 34 PRACTICE AREAS AND RECOGNISES 74 INDIVIDUAL LAWYERS

In the Chamber 2025 UK Guide released today, BCLP received 34 practice area rankings and 74 individual lawyer rankings.

The firm retained all five Band 1 rankings in the following practices:

- **Planning**

- **Transportation – Rail: Rolling Stock**

BCLP's Competition Law: Private Enforcement practice was elevated to a Band 2 ranking.
