## **BCLP DEAL TEAM ADVISES STIFEL IN CONNECTION WITH ACQUISITION OF BRYAN, GARNIER & CO.**

A Bryan Cave Leighton Paisner (BCLP) deal team led by St. Louis Office Managing Partner Ryan Davis, Tax Partner Cathryn Benedict and M&A Associate Jordan Buchheit and consisting of attorneys based in the United States, the United Kingdom, France and Germany advised Stifel Financial Corp. in connection with its agreement to acquire Bryan, Garnier & Co., a leading independent full-service investment bank focused on European technology and healthcare companies. Terms of the transaction were not disclosed.

Stifel was named "US Mid-Market Equity House of the Year" by International Financing Review (IFR), recognizing outstanding capital markets achievements in 2023.
